 - a. sewage treatment capacity and usage analysis;
 - b. discuss testing of blended water and final water quality;
 - c. reuse plant facilities at Cinco Regional Wastewater Treatment Plant;
 - d. Phase 2 Reclaimed Distribution System design and construction;
 - e. irrigation retro fit for phase 2 of reuse system;
 - f. chloramine conversion of water plants;
 - g. Jasper Well No. 2;
 - h. ultraviolet system replacement at South Wastewater Treatment Plant;
 - i. design of District facilities;
 - j. update on preparation of surplus funds application; and
 - k. deeds, easements, consents to encroachment, right of entry agreements, acquisition of property, and requests to transfer or reserve water and sewer capacity.
8. Funding of regional facilities and authorize appropriate action.
9. Update regarding litigation involving U.S. Army Corps of Engineers and authorize appropriate action.
